



# TWENTY-FIVE YEAR LIMITED WARRANTY

The Econoburn wood-fired boiler is warranted – to the original retail customer – to be free of defects in material and workmanship for a period of 25-years. Econoburn does not warranty parts damaged by freezing, overheating, excessive pressure, use of unauthorized fuels, or abuse. This warranty excludes the near-boiler piping and electrical components including aquastats, thermostats, temperature-pressure gauge, relief valve, and circulator pumps as they are covered under their manufacturer’s warranty. The boiler draft fan, controller module, refractory, turbulators, doors, and all boiler parts excluding the pressure vessel which has its own warranty (see below) are under warranty for 5-years from the date of purchase. Econoburn, at its option, will repair or replace the defective part, though labor charges to remove and install repaired or replaced parts are the responsibility of the boiler owner.

The boiler pressure vessel is under warranty for 25-years. If the pressure vessel should fail within the first 5 years of service – starting with the date of purchase – Econoburn will, at its sole discretion, repair or replace the boiler FREE of charge to the boiler owner (installation charges and shipping excluded). After 5-years, Econoburn will, at its sole discretion, repair (free of charge) or discount the current retail price of a new equivalent Econoburn boiler to the boiler owner according to the following chart (installation charges and shipping excluded):

Year	Replacement Boiler Discount*
0-5	100%
6	70%
7	60%
8	50%
9	40%
10	30%
11-25	20%

This warranty is limited to the repair or replacement of any part found to be defective under conditions of normal use. The maximum liability shall not exceed the price of the part claimed to be defective. Econoburn is not responsible for the cost of plumbing, antifreeze, shipping, or any other indirect costs. No unauthorized adjustments or repairs will be covered by warranty. Econoburn specifically disavows any other representation, warranty, or liability related to the condition or use of its product.

\*For example, if in year 7, Econoburn, in its sole discretion, decided to replace a failed boiler (instead of repairing it), and the then-current retail price of an equivalent boiler were \$9,000, Econoburn would offer the boiler owner a discount of \$5,400 (60% x \$9,000) on the purchase of the equivalent boiler.
