LIST OF EPA CERTIFIED STOVES, INSERTS AND FIREPLACES

In 2015 the U.S. Environmental Protection Agency (EPA) strengthened its clean air standards for residential wood and pellet heaters to make new heaters significantly cleaner and improve air quality in communities where people burn wood for heat. The New Source Performance Standards (NSPS) mandate emissions limits of 4.5 grams/hr for both catalytic and non-catalytic wood and pellet heaters. In Washington State the limits are 4.5 grams/hr for non-catalytic wood and pellet heaters.
